INTRODUCTION

The Centre for Social Studies (CSS) is an autonomous social science research institute. It was founded by late Professor I.P. Desai in 1969, as the Centre for Regional Development Studies. It receives grants for its recurring and non-recurring expenditure from the Indian Council of Social Science Research, New Delhi, and the Department of Higher and Technical Education, Government of Gujarat. Besides multi-disciplinary research, the Centre is involved in providing guidance to Ph.D. students, consultancy, training and evaluation.

Although most of the research studies undertaken by the Centre are confined to Gujarat, work relating to other parts of the country is also being carried out for purposes of comparative analysis and to help develop a pan-Indian perspective.

Research activities at the Centre are informed by a reflexive awareness of the social role of the researcher and the nature of social science research. Though the expression 'social science research' is of relatively recent origin, the process of acquiring knowledge about society has a much longer and complex history. There have always been different approaches to the understanding of social reality and to the application of such knowledge to social transformation. For some, it has been an enterprise aimed at enabling the seeker of knowledge to transcend the social reality around him/her for personal salvation. Other analysts of social processes have claimed to be 'value free' even in their concern for an improved social order. In our view, researchers are always a part of the social reality and their concern must emanate from that reality. Their response cannot be only to try and change themselves in order to transcend the world within which they live. They have to understand society, identify what needs to be changed in it, and suggest ways of bringing about this change.

The primary concern of the Centre is to study the structure and processes of Indian society. At one level it generates primary data from field research; at another level it seeks theoretical formulations that would deepen our understanding of the Indian social reality and identify possibilities of and constraints in the building of a just, participatory and egalitarian social order. Without ignoring the essential dialectical interaction between theory and empirical observation, the normal methodological approach at the Centre is to move from a sound empirical base to more generalisable propositions. As a result, the research here has concentrated on social and economic deprivation, social tension and integration, with particular focus on development and planning processes. Even while members of the faculty pursue different studies, their individual endeavours are linked by a common normative orientation that seeks to facilitate social change.

The Centre's faculty, though small in number, represents a variety of disciplines, such as sociology, economics, political science, geography, computer science, philosophy, anthropology and social work. Apart from team work among the faculty, collaborative studies with scholars from other institutions are also undertaken. The CSS is also currently planning to consolidate its initiatives in training teachers, researchers, policy makers, implementers, NGOs, social activists, etc.

The Centre makes available its specialized library, documentation, and data processing facilities to both individual and institutional users.

At present the Centre's studies are focused around the following themes:

- a) Human Resource Development;
- b) Development, Displacement and Rehabilitation;
- c) Human Rights, Civil Society and Governance;
- d) Social and Religious Movements: Conflicts, Struggles and Violence;
- e) Stakeholders' Analysis and Social Impact Assessment;
- f) Social Responsibility of Corporate Sector;
- g) Coastal Studies;
- h) Health Studies;
- i) Micro Finance and the Poor.

I. STUDIES COMPLETED

1. Solid Waste Management – Mid-Term Evaluation of Door-to-Door Garbage Collection (DDGC) Programme in Three Municipal Zones of Surat

Solid Waste Management (SWM) has of late become a major concern in urban management. It is also becoming a major environmental issue in developing countries like India. In April 2004, Surat Municipal Corporation (SMC) introduced Door-to-Door Garbage Collection (DDGC) programme in three selected zones as per the guidelines of the Supreme Court and Municipal Solid Waste Management Rules, 2000. The DDGC programme has been farmed out to private contractors. It has now been in practice since little more than a year and the SMC now intends to extend the DDGC facility to all parts of the city. The SMC decided to get a mid-term assessment to get an objective view of functioning of the programme. The study is based on primary data collected from people and secondary data gathered from the SMC. The basic sample unit for the study comes from the garbage collection routes under the DDGC programme. A total of 4000 sample units have been randomly selected from all the sample routes, of which 67 per cent are residential and 33 per cent are commercial units.

The study found that DDGC in Surat has been a half hearted attempt in the specific context of total urban management program in sanitation and hygiene. It has been immensely beneficial at household level as the garbage clearance is practically at the door step. The DDGC program was introduced with waste segregated at source but the segregation process has not been initiated. On the basis of recommendations of the study SMC has introduced this program in the rest of zones. The study has also raised certain basic issues with regard to urban planning which may have policy implications. The authors plan to bring out a working paper based on this study. A study on rag-pickers is also planned to be carried out as an extension of this. Commissioned by SMC, Arjun Patel and Vimal Trivedi have carried out this study.

2. Working of Anganwadis in Selected Tribal Talukas of Valsad District

In 1975 “Integrated Child Development Services” (ICDS) was launched across the states to uplift the health and nutritional status of mothers and children. Under this scheme Anganwai centres were opened in villages with a population of 1000 in rural areas and 700 in tribal areas, with an aim to provide supplementary nutrition, preschool education, health awareness and immunisation to enhance overall health of mother and the child. The present study was aimed at assessing the functioning of Anganwadis and utilization of its services by the target population i.e. women and children.

The study was carried out in the Dharampur and Kaparada talukas of Valsad district in Gujarat. A random sample of 20 villages were selected from each of the talukas.

Primary data were collected through interviews and focus group discussion to elicit responses from Anganwadi workers, helpers and women.

It was found that the Anganwadis have achieved limited success in realising various objectives of ICDS. Apart from supplementary food and immunisation, services like pre-school education, health awareness, dispersion of medicines and home visits are highly irregular. These are further aggravated by the infrastructural constraints and low awareness of communities towards services provided by these centres. Sponsored by the Bhansali Trust, Surat the study was conducted by Ratnawali Sinha and Sudarshan Iyengar.

II. ONGOING PROJECTS

1. A Study on Health Status and Needs Assessment in Slums of Surat

SEWA promoted Lok Swasthya Mandli is interested in starting public health programmes in 23 slums of Surat city. Before developing and implementing them, SEWA wants to know the current health status and needs in the community through a base line survey. CSS is helping SEWA in conducting this survey which will probe aspects like socio-economic status (SES), morbidity and mortality, health care-seeking behaviour, burden of health care expenditure, suitability of introducing health insurance, access and utilization of public and private health care facilities, reproductive and child health (RCH) etc. The project has been funded by the Lok Swasthya Mandali. Commenced in October 2005, a summary of major findings of this study has been submitted. At present the qualitative data collection is going on and a final report is expected to be ready by December 2006. A paper on urban health is also being planned after submission of final report. Akash Acharya is conducting this study.

2. Dalit Situation in Maharashtra: With Reference to Conflict Mitigation Process

The study is aimed at understanding the nature of social conflict in the state of Maharashtra and to work out mitigation strategies to minimise such conflicts. It has three components: viz. (i) taking an aggregate view of social situation among Dalits in Maharashtra; (ii) conducting three detailed case studies on major incidents of atrocities or conflicts and; (iii) preparing a statement on the agenda for conflict mitigation. The project commenced in 2005. The core report on Dalit Conflicts in Maharashtra has been completed and submitted to the OXFAM which is sponsoring this research. The other components are now being dealt with and final report will be submitted by June 2007. Satyakam Joshi is directing this project.

3. Ethnography of Fishermen in Gujarat: With Special Reference to Recent Developments in Coastal Zones

This study aims at understanding the community of fishermen in Gujarat. Recent developments in coastal areas particularly in the wake of post-1991 developmental policy and programmes have affected the fishermen significantly, particularly those engaged in traditional fishing practices. The study is aimed at exploring as to how activities concerning industrial development, port activities, aquaculture activities and the salt making industries have affected the traditional fishermen. It will also examine the socio-economic, cultural and political aspects of the fishermen community. Much of the data for this study are being gathered through qualitative instruments. The fieldwork is over and the first draft of the report is ready. Initiated in December 2005, this research is going to be concluded by end of March 2007. Supported by the CSS, the study is being conducted by Arjun Patel.

4. Functioning of Panchayati Raj in Schedule Area of Gujarat

Gujarat has 14 per cent of tribal population that resides in 11 districts of Gujarat. As per the Constitution of India, tribal areas of Gujarat fall under the Vth Schedule of the Constitution. This Schedule has special provision for the tribals. In 1997, in accordance with this provision, the Gujarat Government had passed the Panchayat (Extension) Schedule Area Act (PESA) especially for tribal areas. This Act gives more power to the tribal village panchayats and Gramsabhas. Five years have passed after introduction of this act. This study aims at assessing the impact of this Act on tribal society. Both primary and secondary sources have been utilised for data gathering. Documents and information available at various Government and non-government agencies are the major secondary sources whereas primary data are being collected through interviewing village panchayat members of eleven tribal villages selected from four tribal districts of Gujarat, i.e. Dangs, Valsad, Surat and Narmada. The project was initiated in December 2004 and is likely to be completed in June 2007. The Draft report is ready. Sponsored by Aman (Charitable) Trust, New Delhi, Satyakam Joshi is the directing this study.

5. Globalisation, Gujarat State and Welfare for Poor

The present study on Gujarat is part of a larger inquiry on 'globalization and Indian State'. It focuses on the changing policy of federal states since 1991 towards social welfare programmes and their consequences for the poorer and vulnerable sections – small and marginal farmers, agriculture labourers, workers in informal sectors and dalits and adivasis. The study is aimed at trying to gauge the condition of poor in reference to welfare programmes before and after 1991. It will focus on the performance of the State government in three social sectors - labour, welfare and employment; health and education. The study will be based on secondary data—government reports, state budget documents, NSS data and other studies. Information will also be gathered through interviews, personal visits and observations. Data collection is over and report writing is in progress. Commenced in January 2006, this is a collaborative effort and is funded by the National Foundation for India, New Delhi. The study is headed by Ghanshyam Shah. Kiran Desai from Centre for Social Studies, Surat, and Hemantkumar Shah of the H.K. College of Arts and Commerce, Ahmedabad are co-partners in the project. The study is expected to be concluded by end of 2006.

6. Impact of Salinity Propagation and Ground Water Pollution on Rural Households in the Coastal Area of Gujarat State

The dry land salinity and ground water pollution manifest not only in the increased cost of drinking water to the rural households but also has implications in terms of reduced agricultural production, loss of biodiversity, impact on human health etc. The study aims at understanding the impact of salinity propagation on rural households living in the coastal areas of Gujarat State. The study uses production function and differential expenditure methods to analyze the agriculture production losses due to land degradation induced by salinity ingress. Initiated in October 2004, the study is expected to finish by December 2006. Sponsored by the Indian Council of Social Science Research, New Delhi it is being conducted by Jyothis Sathyapalan.

7. Mapping of Reproductive Health Care Seeking Behaviour of Women and Service Provisions in Selected Tribal Areas in Gujarat

This study is aimed at understanding women's perceptions and practices regarding reproductive health and related service seeking behaviour among them. It maps the pathway for women's service seeking behaviour and also documents their access of public and private health services. Focus of the study is on aspects such as pregnancy, child delivery, post-natal care, abortion, sexually transmitted diseases and reproductive tract infections. Core field areas for the study are tribal districts of the south Gujarat region, namely, Valsad and Dangs. Both quantitative and qualitative methods will be used for collection of data. The research was commenced in the year 2004 and field work part is over. Analysis of the gathered data is in progress and the final report is likely to be concluded by December 2006. A local NGO "ARCH" is a partner in this study which is supported by *Cehat* and Healthwatch. Ratnawali Sinha and Sudarshan Iyengar are working on this project.

8. Monitoring and Evaluation of Sardar Sarovar Narmada Project Affected Families (PAFs)

The study aims to evaluate the rehabilitation package provided by the Sardar Sarovar Project Authority (SSPA), Vadodara. The task of census enumeration has already been completed in which data have been gathered from 185 new sites and 10225 families (PAFs). A sample has been drawn from this census. Along with main report four specific case studies have also been conducted. As part of this project following case studies have been prepared:

At present the main report dealing with the Gujarat state is being written. Sponsored by SSPA, this study was directed by Vidyut Joshi till August 2004. It is currently being looked after by Jayshree Soni. The project was launched in January 2002 and is likely to be completed by December 2006.

9. Role of Gandhian Ideas and Constructive Activities in the Present Day Context of Gujarat

This study examines the role and activities of Gandhian institutions in Gujarat with reference to social transformation. Analysis of the component of communal harmony in their programmes and its impact especially with regard to recent communal holocaust in Gujarat is the focus. Mainly qualitative methods of personal interviews, visits to the organisations, focus group discussion as well as collection of information through secondary sources are being applied. The project began in June 2005 and is expected to be concluded by December 2006. Draft report of the study has already been submitted. Sponsored by AMAN trust, New Delhi, this study is being conducted by Satyakam Joshi and Kiran Desai.

10. Study on Dalit Members of Social Justice Committees in Gujarat Panchayati Raj Institutions: An Evaluation

Social Justice Committees in Gujarat Panchayati Raj Institutions (PRIs) is a unique feature. These committees have been set-up at all levels of the PRIs. Elected representatives of PRIs belonging to Scheduled Castes and Scheduled Tribes are members of these committees. This study tries to evaluate as to (i) how far these committees are able to provide social justice to SCs and STs, (ii) whether these are able to make any impact on the all-round development of these sections, and (iii) whether they have made any impact in terms of decision-making process at the PRI level? Around 100 Dalit elected representatives from the Taluka and Zilla Panchayats are being interviewed. Started in June 2005, it is likely to be completed by March 2007. Report writing is in progress. Sponsored by OXFAM, Delhi, this study is being carried out by Satyakam Joshi.

11. Understanding Socio-Economic Impact of Marwar-Mundwa Mining Project

Mining in India has been considered as an indispensable industrial activity as it provides not only revenue to the state and central governments but also employment opportunities to the growing work force, in general, and those inhabiting the mining regions, in particular. In a much broader way, mining also contributes through its link with other economic activities. For instance, the mine itself may purchase raw materials, equipments, electricity, food, services, and many other inputs from the local market. The likely expenditure incurred by the miners and their families on a daily or a periodic basis may stimulate local production of household goods and services. Thus, mining has forward as well as backward linkages. However, like any other activity, it involves certain costs, which may broadly be categorised under economic, social and environmental accounts. Therefore, the extent of overall benefits to a region from mining depends on the net difference between returns and costs. It is within this context that the present study intends to examine the socio-economic impact of Marwar-Mundwa mining project specifically on settlements coming under the lease area.

Funded by the Gujarat Ambuja Cements Ltd. (GACL), the study was commenced in April 2006. Subsequent to preliminary visits to the site and surrounding field areas, a schedule has been prepared for its administering to a randomly selected set of households residing in the mining lease area. With the initial pre-testing of the schedule being over, it is now being finalized for the field-work. The study, being carried out by Gagan Bihari Sahu and Biswaroop Das, is expected to be completed by March '2007.

12. Mutually Aided Co-operatives and Delivery of Micro-Finance to Low Income Households: Experience from Orissa

Across regions, a broad range of financial institutions offer alternate micro finance models with varying logic to address local variations and target groups. Among them, Mutually Aided Co-operatives (MACTs) are relatively recent structures delivering micro finance to low income households. While these are individual membership based organisations, they have often emerged through federating SHGs and are able to gain and retain a legal status. It is through such a status that these societies can mobilise savings from their members and provide micro finance services like credit on terms and conditions defined by themselves. In this context, the present study is aimed at exploring the functioning of MACTs and also as to how these societies deal with their clients while delivering micro finance services at different locations.

Funded by the Friends of Women's World Banking (India), Ahmedabad, the study was commenced in April 2006. A good deal of data from NGOs that have adopted the MACTs as a means of delivering micro finance has already been gathered through interviewing individual households as well as by conducting group interviews from select villages in different talukas of Kalahandi, Nayagarh and Khurda districts in the state of Orissa. A draft report is being prepared which is expected to be finalized in October 2006. The study is being carried out by Gagan Bihari Sahu and Biswaroop Das.

13. Socio-Economic Condition of Rag pickers: A Case Study of Surat City

In our country more than ninety per cent of the solid waste is disposed by land filling. The dumping sites are normally outskirts of cities or located in law lying areas, closer to the slums and squatters colonies. Due to this unscientific approach, a large number of children, youth and women from poor families engage in scavenging. Over the years one can notice a significant growth in the population of rag pickers. The rag pickers emerge from low socio-economic groups and live in poor conditions without state support. They are exposed to serious health hazards as the community containers contain bio-medical waste and other hospital wastes. As per one estimate, in Surat city alone around 1500 rag pickers earn their livelihood through this activity. They earn between Rs.75 to Rs.200 a day. Their working conditions are miserable and risky. Many NGOs like Navsarjan in Surat, SEWA in Ahmedabad and Rupani trust in Rajkot are taking interest in rag pickers for the segregation process and the sale of waste for their livelihood. The rag pickers play a very important role in the segregation of waste. While research on DDGC system of SMC was going on, this issue had emerged. This study is being financed by CSS. Some pilot survey has been done and an interview schedule has been prepared. The project got underway in April 2006 and is likely to be over by June 2007. Vimal Trivedi is carrying out this study.

A workshop on “Tribal Migrant Workers in Gujarat: Problems and Possible Solutions” was organised jointly by the Bandhkam Mazdoor Sanghathan (Disha, Ahmedabad), Gramin Vikas Trust (Madhya Pradesh) and Centre for Social Studies, (Surat) at the CSS on 28 June, 2005. Problems faced by tribals migrating to urban locations in search of livelihood were discussed and policy measures to ameliorate their conditions were suggested. Activists belonging to action groups and NGOs working on this issue as well as academicians interested on the subject participated in the workshop. Kiran Desai co-ordinated this event on behalf of the CSS.

2. National Level Consultation on “Ethics in Social Science Research”

The first national level consultation on the “Ethics in Social Science Research” was organized in collaboration with Cehat (Centre for Enquiry with Health and Allied Themes) and CSER (Centre for Studies in Ethics and Rights) at the centre on 2-3 December 2006. Many eminent Social Scientists as well as directors of ICSSR research institutes participated in the consultation. Ratnawali Sinha and Akash Acharya co-ordinated this event.

3. Training Course on “Research Methodology in Social Sciences”

In recognition of the need for upgrading the research skills of social science teachers, students and professionals, a seventeen days national level workshop on “Research Methodology in Social Sciences” was organized during 6-22 December 2005. The workshop, which was supported by the ICSSR, focused not only on the theory and rationale upon which social research is based but also practical aspects of research which one encounters during different stages of conducting research such as identifying research problem, writing of research proposals, literature review, selection of research methods, report writing etc. The basic objective of the workshop was to provide training in social science research methodology to the scholars and teachers engaged in social science research. Seventeen participants from different parts of the country participated. Vimal Trivedi, Kiran Desai and Jyothis co-ordinated the programme.

4. Training Program in Computer Applications in Social Sciences

A ten day training program in Computer Applications in Social Sciences, sponsored by the ICSSR, New Delhi, was held between February 27 and March 8, 2006. The program was meant for those engaged in survey research and dealing with data analysis. It aimed at providing participants with skills of using computer packages for analyzing social science data in multiple ways. The topics dealt with included quantitative research techniques, survey research, preparing data for analysis, techniques of data analysis, interpretation and presentation of data and the use of SPSS. Through rigorous practical sessions, a strong emphasis was put on imparting skills related to application of techniques while dealing with processing of data on computer. Seventeen participants attended the course. They came from West Bengal, Orissa, Uttar Pradesh, Delhi, Andhra Pradesh, Maharashtra, Rajasthan, Goa, Madhya Pradesh and Gujarat. The

faculty was drawn from the Centre's faculty and from other academic institutions. The program was a rewarding exercise with positive and favourable trainee response. Vimal Trivedi was the course director.

VIII ACADEMIC INFRASTRUCTURE

Library

The Centre's library acquired 377 new books during the year. By the end of March 2006 the total number of books, back volumes and reports has reached 28,570. The Centre subscribes to 100 journals. Of these 85 are Indian and 10 foreign. In addition, 10 journals have been received on an exchange basis and 8 on gratis. The library added to its collection microfilm rolls of Gujarat Mitra, 68 video cassettes and 24 CDs. 510 scholars visited the library during the year.

Documentation

A documentation unit has been set up as part of the library in order to facilitate the research pursuits of the Centre's faculty, and also of scholars working in other research institutions and universities. One of the activities of this unit is to prepare bibliographies on subjects of interest and relevance. Research materials are also photocopied and provided to researchers on request.

Data Processing Unit

Centre's computer facilities are being increasingly used by its faculty, administrative staff as well as social scientists and students from elsewhere. These facilities also help researchers visiting the CSS under its Guidance and Consultancy Scheme. The EDP unit of the Centre provides data processing facility to these researchers. They are also given consultancy services in processing methods and techniques by the EDP personnel. The CSS, through its EDP, helps social scientists in data transfer. Briefly, the Centre's EDP or computer unit is currently addressing three services: 1) Using library programmes suitable to process social science data; 2) Building Centre's own data archive and making it available to researchers; and 3) Training social scientists for more efficient use of computer.

The Centre now has 34 computers, 9 printers, one scanner, one digital camera and a multimedia projector. It has acquired an SPSS, SPSS 8.0 for windows (student version) for social science data analysis, Ethnograph for qualitative data analysis and SOUL software for the library.
